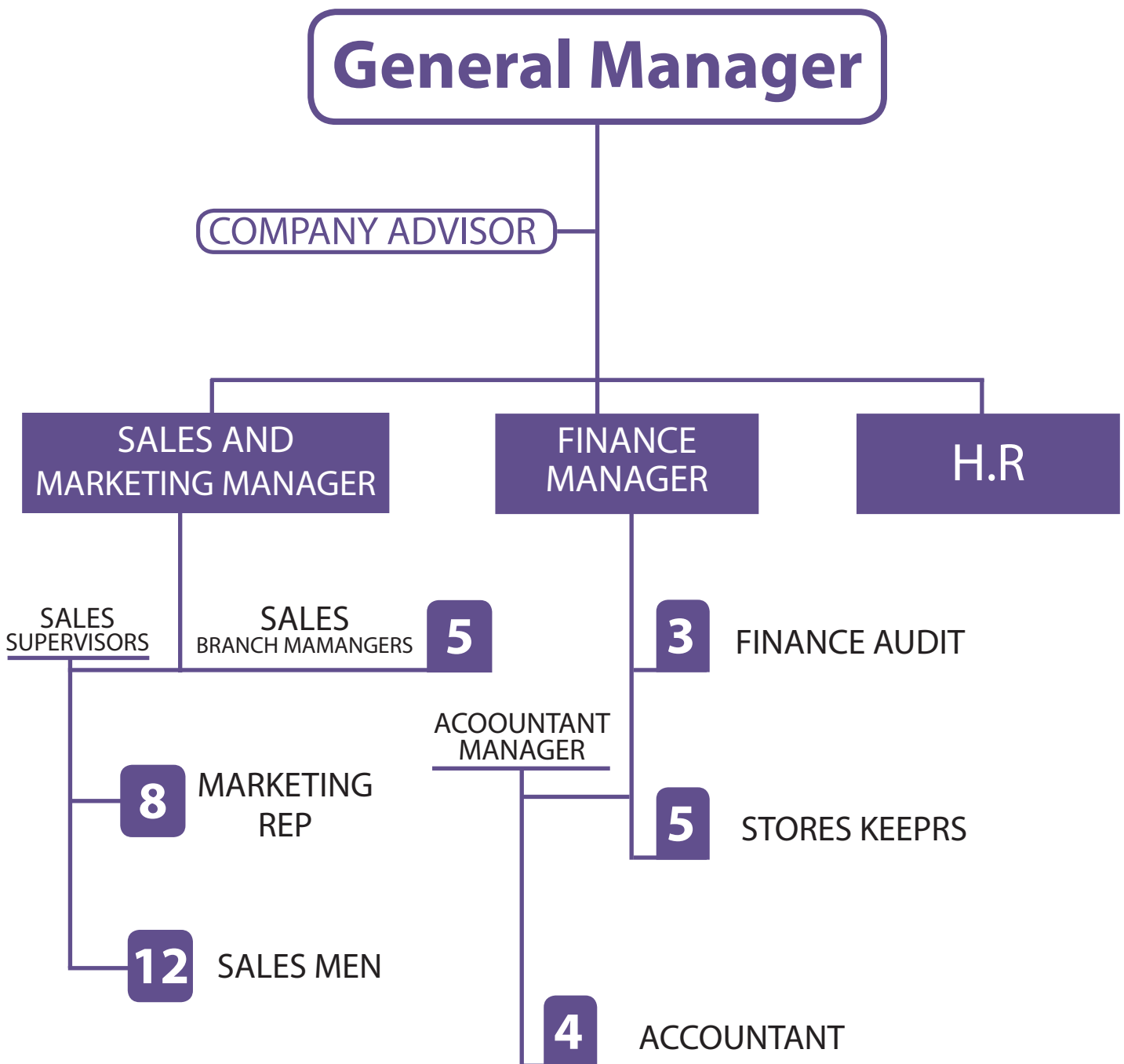

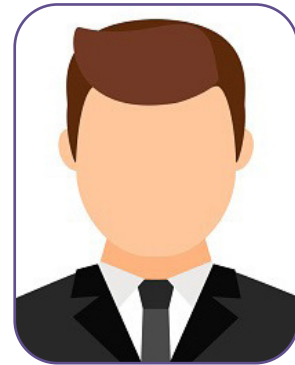
ADMINISTRATIVE STRUCTURE

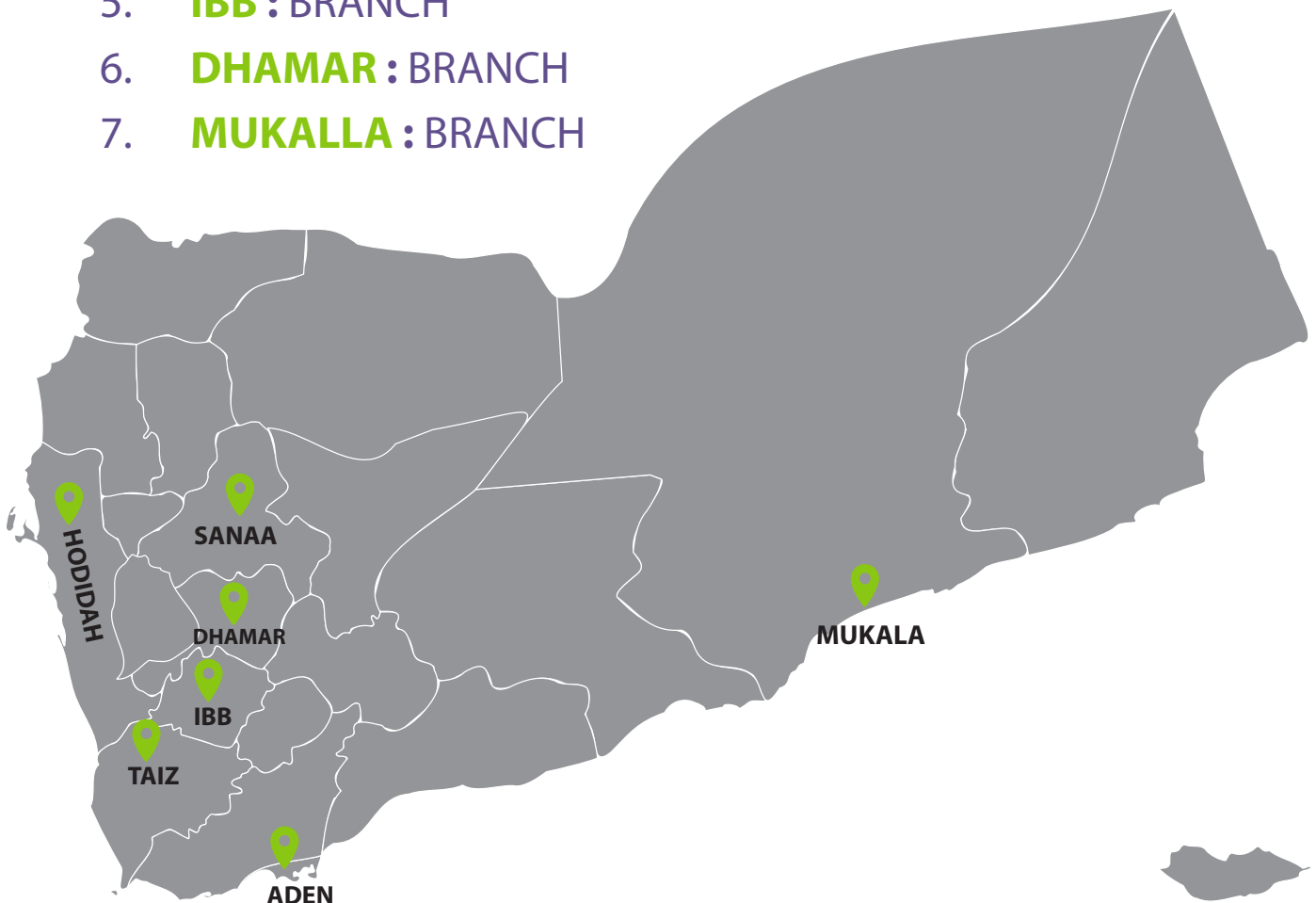
